### **FOOD TRUCK AND PUSH CART ACKNOWLEDGEMENT FORM**

By signing and submitting this form I acknowledge that:

- 1) I have received written consent from any restaurant owner within 100 ft from the proposed location of my food truck or pushcart.
- 2) I have received written consent from any owner of private property of the proposed location of my food truck or pushcart.
- 3) My mobile food truck or pushcart will not occupy on-street parking spaces.
- 4) My mobile food truck or pushcart will be located within all set back requirements as outlined in Elizabeth Municipal Code Section 6-9-30.
- 5) I shall meet and obey all parking and traffic laws.
- 6) My mobile food truck or pushcart is not parked in any ADA accessible parking spaces.
- 7) My mobile food truck or pushcart is parked on a paved or all-weather surface or other approved material.
- 8) Any parking spaces that are occupied do not obstruct parking for the principal use of the property.
- 9) My mobile food truck or pushcart will only be located in a public right-of-way if I have provided the location, time and date to the Town and I have received an approval letter from the Town. My food truck or pushcart will be located within a right-of-way in accordance with the Town Code, particularly, Ordinance 23-01 Section 6-10-30 (b).
- 10) I understand that any food truck or pushcart license shall not apply to separate licensing or agreements with the Town on Town-owned property, such as the "Gesin Lot" or Running Creek Park, except during Town special events, such as Friday Night Markets.
- 11) All refuse generated from my mobile food truck or pushcart has been properly disposed of.
- 12) Sidewalks, roadways, and other adjacent spaces are kept clean and free of any refuse.
- 13) When not in use, only one food truck or pushcart may be stored on a single-family, duplex or multi-family dwelling property.
- 14) I understand that no additional structures, canopies, tables, or chairs are allowed.
- 15) All signage is affixed to the food truck or pushcart except during hours of operation in which I am allowed one (1) menu or sandwich board.
- 16) The property owner has provided written notification to any tenants within a multi-tenant shopping center of the operation of my food truck or pushcart.
- 17) When vending in a public right-of-way, vending will occur from the curb side.

- 18) As a food truck or pushcart operator, I will not obstruct pedestrian or bicycle access or obstruct parking lot circulation or impede traffic.
- 19) My food truck or pushcart will be closed at the end of each business day unless otherwise approved.
- 20) Any food truck or pushcart license shall be good for up to one (1) year until December 31<sup>st</sup> of the current year.
- 21) If I wish to renew my food truck or pushcart license, I will provide an application and notice to the Town no later than 10 business days before the expiration of my current license.
- 22) My food truck or pushcart license will be displayed at all times.
- 23) My food truck or pushcart license may be revoked immediately if found in violation of Town Municipal Code Chapter 6 Article IX and may be subject to punishment by fine and/or denied any future food truck or pushcart license for one (1) year.
- 24) All information provided on and with my application is true and correct to the best of my knowledge and that any false information may result in a delay, denial, suspension or revocation of my mobile food truck and pushcart license.
