April is National Records and Information Management Month!

Records and Information Management Month (RIMM) is celebrated internationally during the month of April to highlight the significant impact records management has on organizations. This past year, the Town has incorporated the use of a software program called Laserfiche to help organize and digitize the copious amount of paper documents that we have stored. One of the benefits of the Laserfiche program is the ability for the public to access many of these documents through a public portal. You can find and access this Public Portal on the Town of Elizabeth website under **Resources > Town Records.** Please be aware that this portal is new and a work in progress. If you are not finding what you are looking for, you are more than welcome to submit an Open Records Request form. This form can be found on our website at https://www.townofelizabeth.org/townclerk.

As part of the Records and Information Management Month, the Town would encourage you to use this opportunity to clean up and organize some of your own personal records. Below are the most recent recommendations for document storage:

Taxes: the IRS recommends that you only keep tax records for 3 years from the date you filed your original return or 2 years from the date you paid the tax, whichever is later.

Paycheck Stubs: Keep for one year to compare to your W-2's and year-end taxes and then you can dispose. **Utility Bills, Credit Card Receipts and Bank Statements**: 1 year unless you claimed them on your taxes, then store with your taxes as recommended above.
